ROAD CLOSURE AT AMERICAN AVENUE IN FRESNO COUNTY

UPDATED: MAY 15, 2017

FRESNO, CALIF. – The California High-Speed Rail Authority (Authority), in cooperation with design-build contractor, Tutor-Perini/Zachry/Parsons (TPZP), announces a road closure at American Avenue in Fresno County. This closure is for construction of an overcrossing that will eliminate an existing rail crossing and allow vehicles to travel over the high-speed rail alignment and the BNSF railroad tracks. The closure is scheduled to begin Thursday, June 1, 2017.

This work is part of Construction Package 1 (CP 1), the first 32-mile stretch of high-speed rail between Avenue 19 in Madera County to East American Avenue in Fresno County.



American Avenue will be closed to thru traffic between Cedar and Maple Avenues for approximately 12 months starting Thursday, June 1, 2017.



Traffic going west on American Avenue will be detoured south on Maple Avenue, west on Lincoln Avenue, then north on Cedar Avenue back onto American Avenue.

Traffic going east on American Avenue will be detoured south on Cedar Avenue, east on Lincoln Avenue, then north on Maple Avenue back to American Avenue

This schedule is subject to change. For up-to-date information please visit BuildHSR.com or the [Caltrans Quickmap](#). Traffic laws will be fully enforced and commuters are expected to be aware of the surrounding activities, remain alert and watch for construction vehicles and personnel. The public is asked to drive carefully and be extra cautious while traveling through the construction areas.

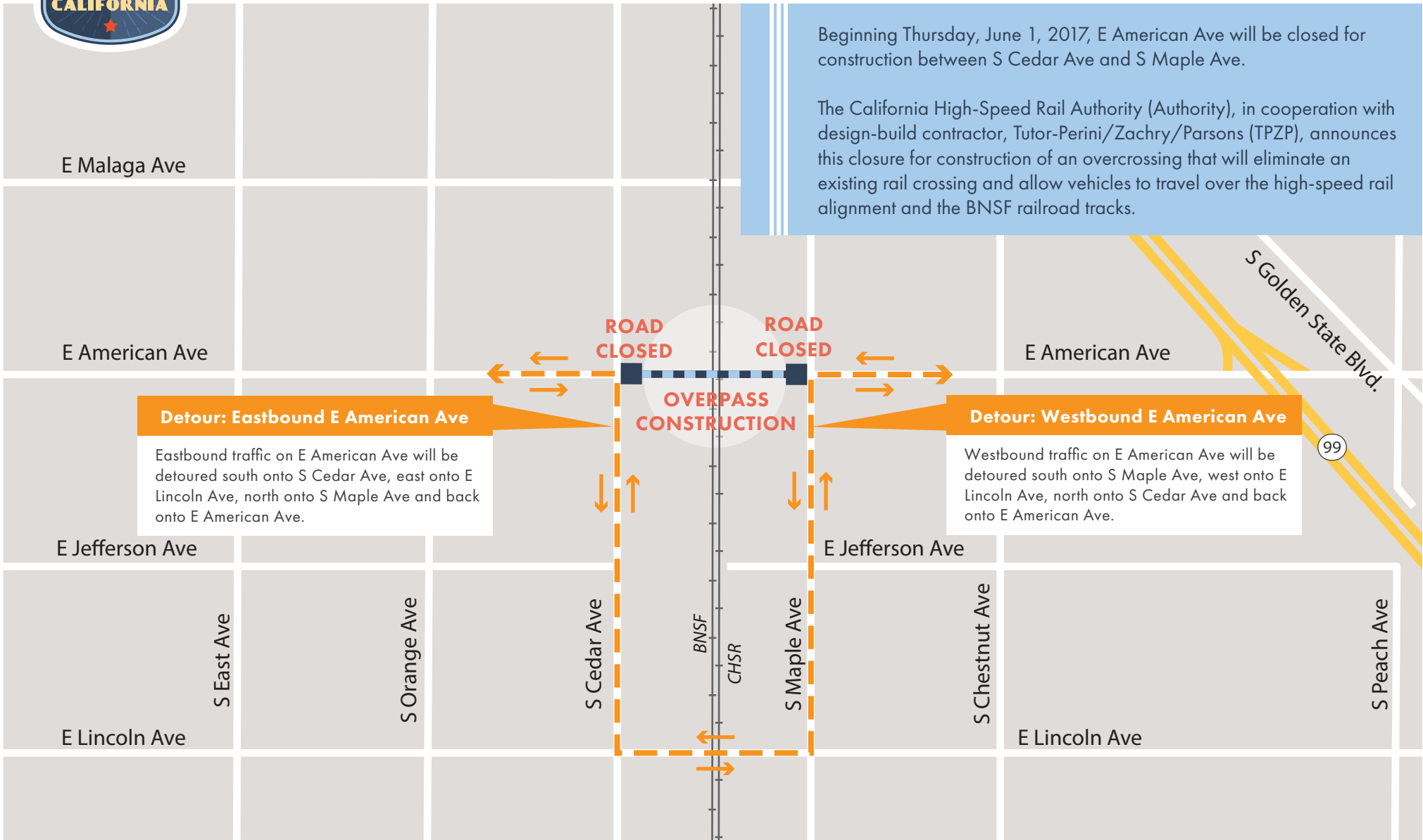

CONSTRUCTION ACTIVITY | AMERICAN AVE CLOSURE

Beginning Thursday, June 1, 2017, E American Ave will be closed for construction between S Cedar Ave and S Maple Ave.

Detour: Eastbound E American Ave

Eastbound traffic on E American Ave will be detoured south onto S Cedar Ave, east onto E Lincoln Ave, north onto S Maple Ave and back onto E American Ave.

Detour: Westbound E American Ave

Westbound traffic on E American Ave will be detoured south onto S Maple Ave, west onto E Lincoln Ave, north onto S Cedar Ave and back onto E American Ave.
