



## CONSTRUCTION & ROAD CLOSURE ALERT

### ROAD CLOSURE ON RICHERT AVE WEST OF GOLDEN STATE BOULEVARD IN FRESNO

ISSUED: OCTOBER 6, 2017

**FRESNO, CALIF.** – The California High-Speed Rail Authority (Authority), in cooperation with design-build contractor, Tutor-Perini/Zachry/Parsons (TPZP), announces the closure of Richert Avenue west of Golden State Boulevard for utility relocation. Work is scheduled to begin Monday, October 16 and continue for approximately one week.

This work is part of Construction Package 1 (CP 1), the first 32-mile stretch of high-speed rail between Avenue 19 in Madera County and East American Avenue in Fresno County.



**Richert Avenue will be closed to through traffic west of Golden State Boulevard. This closure is scheduled to begin October 16 and continue for approximately one week.**



**Richert Avenue traffic will be detoured to Swift Avenue. Drivers are expected to follow road closure signage and may experience delays; pedestrian access will not be restricted.**

Traffic laws will be fully enforced and commuters are expected to be aware of the surrounding activities, remain alert and watch for construction vehicles and personnel.
